RACE CONDITIONS AND DESCRIPTION

- DATE OF RACE : **Wednesday, 6 February 2019**
- PRIZE MONEY : **S\$200,000** (Souvenir trophies will be given to winning owner, trainer and jockey)
- DISTANCE : **1400 Metres (Turf)**
- AGE : **Three year old and above**
- WEIGHTS : **Condition Weights**
- Horses that have not won a race of Class 3 (or equivalent) or more to carry 50kg
 - Class 2 & 3 (or equivalent) winners to carry 52kg
 - Class 1 (or equivalent) or more winners but not a group race to carry 54kg
 - Group 2 & 3 race winners to carry 56kg
 - Group 1 winners to carry 58kg
 - Should the highest weight accepting at the final declarations be set to carry less than 57kg then its weight will be raised to 57kg and all others raised equally
 - Fillies and Mares granted 1.5 kg allowance
 - Any applicable Weight-For-Age allowance will be applied to a minimum weight of 49kg
 - Horses that have not won a race in the 5 starts prior to entry granted 1kg allowance
 - Rider allowances not permitted
