1. ENTRIES

Entry Closing Date:

Sunday 26 February 2022, 2000hrs

Entries must be submitted using the appended registration link. Entry fee for each class is detailed in the show schedule.

Riders with preferred timings or who would be riding more than one horse should indicate the order of their preferences on the entry form. Singapore Turf Club Riding Centre (STCRC) will endeavour to accede to such requests on a best effort basis.

STCRC has the right to refuse entry to riders who make multiple submissions. STCRC reserves the right to cancel any classes or events due to insufficient and/or less than ideal number of riders per class.

Late Entry:

Entries received after the closing date will be considered as late entries. A late entry fee, which is double that of the regular entry fee will apply. Stabling is not guaranteed for late entries.

Late entries for Jumping may be taken up to 30 minutes before the class starts. Late entries will start first in any Jumping classes but can be adjusted at the discretion of the Ground Jury. Any schooling rounds or Hors Concours (H/C) should only commence after the last rider of the class has completed his or her jump. Entry fee for any schooling or H/C round is chargeable (without a late entry fee) and is not eligible for any prizes. Late entries and H/C rounds are permitted at the discretion of the Ground Jury.

Payment for Entries:

All riders must pay for their entries and stabling fees by Friday 3 March 2023, 1200hrs. Riders who fail to pay their entry and stabling fees before the show starts may be refused entry to STCRC.

Any late entries or additional charges incurred during the stay needs to be settled before the horses leave or collection of passports. There will be no interclub billing.

4. RULES AND REGULATIONS

Important Notice: Information regarding acceptance of entries and draw times will be sent to riders via email at least 3 days prior to the competition weekend. Changes to the Starting Order are not permitted after this time, except where Late Entries may be added to the Start of the Draws. General updates of the event and class schedules will be available on the day itself, on the notice boards at STCRC Covered Arena, which will be periodically updated during the show. It is the responsibility of the riders to check both email and notice boards regularly to be kept informed of the latest show updates.

Fédération Equestre Internationale code of conduct for the welfare of the horse

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences at all times.

1. Competition horses' welfare must take precedence over all other demands at all stages during preparation and training. This includes good horse management, training methods, farrier and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threatens the welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

General Rules: The Competition is a National Equestrian Federation of Singapore (EFS)-sanctioned Interclub Show, organised under the following rules:

FEI General Regulations 24th Ed., effective 1 January 2023

FEI Statutes 24th Ed., effective 17 November 2021

FEI Veterinary Regulations 15th Ed., effective 1 January 2023

FEI Jumping Rules 27th Ed., effective 1 January 2023

In any circumstances where FEI rules are not available, the Ground Jury will have the authority to make decisions.

In-House Rules: The Competition is organised under the following rules:

Competitors must wear a helmet with a 3 or 4-point harness correctly fastened at all times when mounted. There will be designated areas to work your horses in the Outdoor Arena and Covered Arena during the competition. Any competitor found riding outside these areas may be disqualified. Riders warming up should pass left hand to left hand. In general, the faster pace has priority and slower horses should give way. Lateral work has overall priority.

The Competition grounds and stable areas must be kept clean and tidy at all times. No littering of the STCRC grounds will be accepted. Tack adjustment, horses standing, etc. should take place off the track and away from working horses. Coaches and parents/guardians must not impede or interrupt other horses using the arenas.

No grazing and hacking around the premises for any school and visiting horses during/throughout the weekend competition.

Stabling: Requests for stabling must be accompanied with the Entry Form. Stabling is available on a limited, first-come-first-serve and per horse, per stable basis. Permanent Stables at \$70 nett per horse per night.

Washing down of horses must be done in the wash bay areas only. All droppings must be removed from the wash bays. Droppings/waste must be removed from the stable daily and disposed of in a proper manner. At the end of the Competition, all stables must be cleared of all horse droppings. A \$50 fine will be imposed for unclean stables.

Horse Floats: Return trips (to and from STCRC) are chargeable at \$40 and subject to availability, on a first-come-first-serve basis. Visiting clubs must submit all relevant entry and declaration forms before the closing date. Incomplete submissions and/or missing information in any of the forms will not guarantee float services for the horses.

Horse Arrival/Departure: Visiting horses will be allowed into the STCRC stables up to one day before the Competition weekend, subject to availability on a first-come-first-serve basis and must leave on the last day of the Competition.

Horse Passports: The original passports must be submitted to the STCRC reception counter upon entering the premises.

**Vaccination
Certificate:**

All horses and ponies intended for participation in this Competition should possess a Health Certificate that certifies them free from Nipah Virus. They are required to be immunised against (a) Equine Influenza (E) and (b) Japanese B Encephalitis (Jap B).

Refer to FEI Veterinary Rules (Ed.2018) Art. 2003: The FEI requirement for influenza vaccination with an initial Primary Course of two vaccinations must be given; the second vaccination must be administered within 21-92 days of the first vaccination. The first booster must be administered at a maximum of six months intervals however horses competing in events must have a received a booster within six months + 21 days (not within seven days) before arrival at the event. Horse may compete seven days after receiving the second vaccination of the primary course.

Horses that have already been immunised must show documentary proof that the vaccinations have been performed by an Official Veterinary Surgeon or Government Veterinary Surgeon. These records must be entered in the horse passport/registration cards. Horses and ponies attempting to enter without up-to-date vaccinations records will be denied entry to STCRC.

Insurance:

All Owners and Competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents and their horses. All Competitors are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and keep their policy up-to-date.

**Organiser reserves
the right to:**

1. Refuse any Horse or Competitor.
2. Cancel, Merge or Divide any Classes/Events.
3. Eliminate or disqualify any rider or spectator behaving in an inappropriate manner toward other competitors, spectators, or staff.
4. Alter the advertised times if necessary.
5. Bill any participating club the cost of cleaning stables.

5. COMPETITION RULES

Competition Grounds: Covered and Outdoor Arena – Polytrack surface

Competition Rules: Horses may participate in up to three Classes per day in a single discipline. School horses may compete in more Classes (restricted to low level only) if specific permission is obtained from the Riding School Management.

If not wearing a competition jacket, a solid coloured short/long sleeved shirt with tie, choker or stock (for Men) or a white Mandarin collar (for Women) are permitted. Leather chaps of the same colour as jodphur boots are permitted instead of tall boots in all Jumping Classes. Fawn, Cream or White breeches must be worn in all classes. Official Club t-shirts may be worn in Preparatory Dressage. Body protectors are permitted in all Classes, but care must be taken with respect to potential heat exhaustion.

Except as noted above, dress, tack and participation must conform to the respective Discipline Rules as follows:

- Jumping classes will be run under FEI Rules for Jumping events, specifically under Table A (FEI Jumping Rules Art. 236). For all classes under 100cm, Table A will be modified as follows:
 - 2nd Disobedience = 4 penalties
 - 3rd Disobedience = Elimination

All instructions from Stewards and Officials are to be followed without dispute or delay, otherwise the competitor is liable for disqualification or elimination.

Wet Weather Plan: In case of rain, all participants, coaches and spectators are required to bring sufficient rain protection to avoid congregation at the side of the arenas and/or tents. In case of thunder and lighting, the Competition and activities will cease and all persons are to return to the stables while adhering to required safe distancing at all times.

Prize Giving Ceremony: Rosettes will be presented to winners during prize presentation ceremonies immediately after each class. Competitors must be neatly dressed in full competition attire as a sign of respect for the Show Sponsors and Officials. Failure for a placed competitor to attend the prize giving may result in a forfeit of any prize and/or prize money. A placed competitor may appoint someone on their behalf to collect the prize for them.

Winners will need to submit their details at <https://forms.office.com/r/QUT07B18bg> within one week of the Competition date for prize money collection.

Appeals: Appeals against any judging decisions, placing or events impacting the results of any class must be lodged with the Show Director in writing within 30 minutes of the official announcement of the class results. All appeals must be accompanied by a deposit of \$50 which will be returned in the event the appeal is upheld. The Appeals Committee will review all appeals and announce its decisions as soon as possible pending the time taken to gather and review evidence. The decision of the Appeals Committee is final.

- iv) To be filmed, photographed or interviewed as a participant in the show when requested to do so by any officer or official of the organizer and grant permission to use my likeness in a photograph, video, or other digital media (“photo”) in any and all of its publications, including web-based publications, without payment or other consideration
